Yes, YOU can go to Convention 2015! Thanks to funds donated to "leadership development," our Branch is offering stipends of up to \$475 per person to encourage you to attend the AAUW Convention in San Diego, June 18-21. If you have never attended an AAUW Convention, take advantage of this opportunity to participate in exceptional workshops – to improve your leadership and communication skills, to hear inspiring speakers, to find out about the latest AAUW projects and initiatives, and to have a wonderfully good time with fellow San Jose Branch members and members from across the country. Stipends will go first to Board members who have never attended a convention, then to any Branch member. Since we don't know how many members will request stipends, the Board hasn't set a limit on the number to be offered. We may use a first-come-first-served system or have a drawing. Whatever the procedure, I urge you to contact me as soon as possible if you want to attend and to register early. If you register by January 15, the full-convention registration fee is \$449; through March 31 it is \$475, and thereafter \$525 (Saturday night banquet is an extra charge of \$120). AAUW Funds in Action

In February, you will receive the annual AAUW San Jose Funds solicitation letter. Donations directed to education provide many women with educational and research opportunities. Among the 2014-2015 recipients of AAUW Funds are:

- **Gabriela Montes** (UC-Santa Cruz) studies the properties of stellar winds. This will extend our understanding of massive stars and their impact on their host galaxies. She also collaborates with students from underrepresented groups and encourages them to pursue higher education in science.
- **Eileen Moore** (San Diego State) studies the relationships between alcohol, brain development and behavior. Her current work focuses on the longterm effects of heavy prenatal alcohol exposure on the brain and behavior, as well as the identification of behavioral biomarkers of effect.

- Adriana Romero-Olivares (UC-Irvine) is interested in understanding the evolutionary process of microbial communities adapting to climate change. She conducts field studies in an Alaskan forest and hopes to uncover the evolutionary processes leading to adaptation and the implications for the global carbon cycle.
- **Elizabethe Manzi** (Stanford) majored in civil engineering with a minor in international engineering at the University of Maryland. She also competed in NCAA Division I gymnastics, gained research experience in hydrology, and was a part of the engineering honors program. She is attending Stanford in the fall to earn a bachelor's degree in sustainable design and construction, with the goal of pursuing a career in urban development.

AAUW and Legal Advocacy Fund Projects

As we begin this New Year, let us reflect on some of AAUW's Legal Advocacy Fund (LAF) achievements during 2014:

LAF is supporting a gender discrimination case in college athletics, *Moshak v. University of Tennessee*. This case alleges discrimination and unlawful retaliation under Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and the Equal Pay Act of 1963.

The California State Personnel Board reinstated a 2006 ruling in favor of LAF-supported plaintiffs Paul Thein, Laurel Wartuft, and Michelle Jaurequito. The plaintiffs filed whistleblower retaliation complaints against Feather River Community College, alleging they were terminated after raising concerns about Title IX compliance and discrimination.

The Massachusetts Commission against Discrimination (MCAD) upheld a ruling in favor of LAF-supported plaintiff Lulu Sun in her gender and race discrimination case against the University of Massachusetts, Dartmouth. MCAD upheld the 2011 decision, ordering the university to pay damages and conduct anti-discrimination training.

These are just of the few of the important legal issues that affect women today. Fair pay, promoting equal women's rights, and protecting choice are all areas that need to be addressed. The Legal Advocacy Fund helps to ensure that these issues are addressed. Early next month, you will be receiving the annual appeal letter asking you to donate to AAUW Funds and LAF. Your donations are crucial to the on-going support of legal cases. Please consider making a donation to LAF. **Happy New Year to all!**

AAUW Issues and New Congress and State Leaders

The 2014 mid-term election and run-offs are over. AAUW Public Policy leaders are analyzing, discussing and communicating with state and branch leaders about the results and (drum roll), we won! AAUW's and friends' voices were heard loud and clear on ballot initiatives on issues including the minimum wage, paid sick days, and equal rights. Here's a summary rundown on how our issues fared in state elections.

AAUW-supported ballot initiatives did well. Measures to increase the minimum wage were successful in four states and all did so with healthy majorities. We also saw Massachusetts pass a paid sick days measure pretty handily. And anti-choice initiatives were rejected in Colorado and North Dakota. This is all very good news and bodes well for AAUW efforts to continue to push our priorities at the state level while gridlock reigns in our nation's capital.

Voters are quite comfortable contradicting themselves especially Independent voters. AAUW-supported ballot initiatives overwhelmingly went our way (go team!), yet the electorates in those same states chose senators who strongly oppose the very initiatives the body politic passed. This contradiction seems to be especially true for Independent voters, who will take on even more significance in the 2016 presidential election.

Some barriers were broken, but it was mostly a rough election for women candidates. Thanks to her specialelection victory, Rep.-elect Alma Adams of North Carolina will become the 100th woman member of the current 113th Congress. This is the highest number of women in Congress in U.S. history. Despite breaking into three-digit range, it looks like the proportion of women in both the Senate and House will change very little. As for barriers broken, West Virginia and Iowa for the first time elected women to the U.S. Senate, with Iowa's Joni Ernst also

becoming the first woman elected to Congress from Iowa overall. Gina Raimondo will be Rhode Island's first woman governor. Rep.-elect Elise Stefanik Jacqui Gustaferro and Gloria Leonard, Co-Chairs, Public of New York, at age 30, is now the youngest woman ever elected to Congress. New Jersey sent its first African American woman to the House, and Utah's Mia Love is the first-ever Republican African American woman elected to Congress.

> ID laws suppress turnout and voting. A new law requiring photo identification for voters in Texas prevented some longtime voters from casting their ballots. Voters in North Carolina also reported trouble related to a new policy, and voters in Georgia reported being unsure their votes had been processed. Laws that require voters to show identification reduce turnout among African Americans and young voters especially.


