

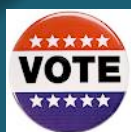

On October 24, 2012, AAUW released ***Graduating to a Pay Gap: The Earnings of Women and Men One Year after College Graduation***.

The study explores the earnings difference between male and female college graduates working full time, one year after graduation using the latest nationally representative data available. The report compares "apples" to "apples" by looking at the pay gap after controlling for various factors known to affect earnings, such as occupation, college major, and hours worked. The report also looks at one immediate effect of the pay gap for many women, high student loan debt burden.

Fair Pay Act Champion Cites AAUW Support

Lilly Ledbetter, whose lawsuit against the Goodyear Tire and Rubber Company was the basis for the Lilly Ledbetter Fair Pay Act of 2009, addressed the American Federation of State and County Municipal Employees (AFSCME) convention in San Jose September 21. President Marilyn Jackson, LAF VP Mary Barry and eight other AAUW San Jose members attended the event as guests of AFSCME. The Fair Pay Act was the first piece of legislation President Obama signed as President.

Ms. Ledbetter spoke about her days as a youngster picking cotton, and her determination to achieve financial success for herself and her family. After nineteen years as a manager at Goodyear, she learned that she was being paid 40% less than her male colleagues. Her determination to seek redress resulted in support from the AAUW Legal Advocacy Fund for the lengthy legal process that culminated at the Supreme Court. During her address in San Jose, Ms. Ledbetter repeatedly thanked AAUW for its support over the years. AAUW provided financial support for the lawsuit, filed an Amicus brief with the Supreme Court, and sent members to attend the legal proceedings. Ms. Ledbetter's courage and determination have changed history—and AAUW and our Legal Advocacy Funds have been partners in this momentous work.

99% of All AAUW Members Vote

We did it for AAUW's mission and our public policy priorities and we did it for all of our members. You can do it too. Get out the vote!

Engaging our Tech Trek/Tech Excellence Girls

Career women immersed in Science, Technology, Engineering and Mathematics (STEM) serve as the bridge between our 32 Tech Excellence girls at John Muir Middle School and "real world" of problem solving. They model what it is like to be a career woman and introduce concepts for improving our quality of life.

On October 17, Julie Kahrnoff, Living Wetlands Program Coordinator of the Don Edwards San Francisco Bay National Wildlife Refuge Environmental Education Center talked to the girls about how everyone contributes to the pollution of our waterways. Working in small groups, the girls developed a parcel of land with a "million dollar budget". They learned how each building affects its neighbor downstream. Lesson: Every individual impacts our watershed! The next week the girls travelled to the Seymour Marine Discovery Center (SMDC) at Long Marine Laboratory (LML) in Santa Cruz, to explore how marine research helps conserve the ocean.

The next class is on November 1, "Green Technology – Your home: The cost of plugging in!" followed by a field trip on November 15 to the Tech Museum-Solar Circuits and Alternative Energy Lab. Volunteers are welcome!

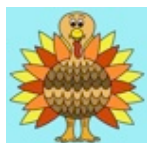
