Public Policy Activities Recap

AAUW San Jose members, friends and family sent over 2,000 letters to low-propensity voters across the country, urging them to participate in the democratic process by voting. While we're all winners for helping with this effort, hats off to Dr. Tara Sood, who wrote 400 letters, and Marna Taylor, who wrote 260! Each of them got support from family/friends; isn't that what success often entails?

We supported 16 California legislative bills this year, writing letters and making calls to legislators, committees, and the governor. While most of these bills were signed by Governor Newsom, he did veto four of the AAUW CA-supported bills that our Branch worked on, including AB 1906 (health of pregnant corrections officers), AB 2405 (housing), AB 3216 (rehire rights of COVID-related layoffs), and SB 1383 (safety of domestic workers).

On Thursday, October 1, seven Public Policy Committee members presented to 40 Branch members on the 12 California ballot measures coming up in this election. Thanks to all for an informative evening. The slide deck is available at <u>CA ballot propositions overview</u>.

Djalaica De Guzman was awarded an AAUW Local Scholarship in 2020. Majoring in Nursing at San Jose State University, she expects to graduate in May 2021. Djalaica notes that the scholarship came at an especially advantageous time for her. She had just moved into a new house with sorority friends when the pandemic began. To make matters even worse, she and her family were in a very rough financial situation since most of them had lost their jobs due to the pandemic. Paying for tuition was going to be really challenging. Happily, our scholarship allowed her to move into her new house comfortably. Additionally, Djalaica was very excited to be rehired at Barry's Fitness Center in mid-August, which affords her the opportunity to indulge in her passion for exercise and staying active.

In early September, Djalaica was offered a job at Santa Clara Valley Medical Center as a Health Services Assistant in the Traumatic Brain Injury and General Rehabilitation Unit. She is excited to learn more and to gain experience in a hospital, working with patients with this type of acuity challenge. This will give her the opportunity to explore a specialty in which she is interested. Djalaica notes that Valley Med is known for this unit and is actually recognized as the only high performing hospital in California for rehabilitation services.

Although graduation is still several months away, Djalaica is already looking into new graduate residency programs. Building the courage to make the big move to a big city away from home, she is reaching out to hospitals in Los Angeles, looking into applying to really great programs such as UCLA, Cedar Sinai, and Children's Hospital LA. She is also applying to many in the Bay Area.

In the just-for-fun category, along with trying to stay active, when she has the chance Djalaica loves "expanding her self-care treatments such as Netflix and skin care routines." One of the shows she's watched recently is about real estate in Los Angeles, which is what inspired her to move there and to maybe get a real estate license in the future. She obviously has a broad range of interests!
