Strong Start and AB 1361 AAUW CA Public Policy Committee Submitted by Susan Karlins, AAUW SJ Public Policy Chair

Srong Start, Santa Clara County Office of Education Early Childhood Care and Education project, promotes the increase and improvement of early childhood quality programs for all SCC pre-school age children. It is their goal to provide universal childcare and pre-school, with special emphasis on under-served communities in the county, a priority of AAUW CA. AAUW CA Public Policy committee supports AB 1361(Blanca Rubio), a bill also supported by Strong Start and the Stopping the Pipeline project of Black Men for Educational Equity, among others. The legislation would take the following actions:

- •Revise and recast provisions relating to the suspension and/or expulsion (unenrollment) of a child from the state preschool program. Existing prohibitions on expulsion are currently flexibly applied.
- •Establish requirements for the use of suspensions.
- •Support continuity between the childcare in the program and at home.
- •Refine and update mental health services, access, and reimbursement protocol.

In addition, the bill would require programs to maintain records on expulsion and suspension and the State Department of Education to collect and annually publish a report with this information. Right now, in California preschool is not mandatory, but research has shown that early child education helps prevent the school to prison pipeline for low-income and minority children. AAUW is supporting programs that improve the opportunities for all children, and especially for under-represented families.

Finally, if you know relations or friends with small children needing childcare, send those parents to Steps to Success, another project of the SCC Office of Education. In this time of continued pandemic, and also an opportunity to resume a normal life, the project builds awareness of the benefits of enrolling and attending early childhood education programs. A Further Update on Giavanni Hurtada, Two-Time Local Scholarship Recipient Cheryl Markman, Local Scholarship Committee

Giavanni Hurtada, first profiled in August 2020, received a Local Scholarship in 2019 and again in 2020. She graduated from San Jose State University in May with a Bachelor's degree in Social Work with magna cum laude honors. During her two years at SJSU, she obtained straight A's, was recognized as a Dean's Scholar in both Spring 2020 and Fall 2020 terms, and was invited twice into the Phi Kappa Phi Honors Society.



Prior to graduation, she was active in the Undergraduate Social Work Association (USWA), Educational Opportunity Program (EOP), and the Chicanx/Latinx Student Success Center.

As part of her degree requirements, Giavanni participated in an internship placement with Zephyr Self-Help Center, a mental health agency under the Santa Clara County Behavioral Health Department, where she served as a peer support worker.

Considering the stress of the past academic year during the pandemic, amplified by the loss of her great grandmother in June 2020 and her great grandfather in January 2021, Giavanni decided to postpone graduate school for one year to recharge her physical self as well as her mental health. In the interim, she plans to seek entry level employment opportunities in the medical, county or educational settings in the field of social work.

She also looks forward to starting a family and having a home of her own. In her free time, Giavanni enjoys reading and writing short stories. Discrimination against Black Transgender and Gender Non-conforming People by Archana Maniar, AAUW CA Public Policy

Increasing attention has been focused on the multitude of ways in which black transgender and gender non-conforming individuals encounter discrimination. A recent study by the National Center for Transgender Equality addressed these forms of discrimination through the National Transgender Discrimination Survey. The study highlighted a variety of economic, safety, and physical and mental health challenges faced by transgender and gender "non-conforming" individuals.

Black transgender people had unemployment rates four times the rate of the general population and twice the rate of transgender people at large. A startling 41% of black transgender or gender non-conforming individuals said they had experienced being unsheltered. Black transgender individuals suffered extreme poverty at a rate of 31% which is twice that of transgender individuals of all races and eight times the general US population.

Furthermore, 50% of black respondents who attended school while expressing their transgender identity or gender non-conformity reported harassment in the survey. Nearly half of black respondents to the survey had attempted to commit suicide and more than 20% were living with HIV compared to 0.60% of the general population.

The findings highlight the profound challenges faced by black transgender and gender non-conforming individuals and point to the need for social justice advocates and government officials to address the intersection between race and gender identity to assure equity of transgender or gender non-conforming citizens. https://www.thetaskforce.org/new-analysis-shows-startling-levels-of-discrimination-against-black-transgender-people/
