

This is the <u>Kanizsa Triangle</u>. Most people see a solid white triangle pointing upwards, an inverted triangle pointing downwards, and a set of black discs. But the fact is, none of these shapes are actually present in the figure. In fact, this image is of "pac-men" and V's, not triangles and circles. This is an example of our unconscious mind using familiar information to try and make sense of what it sees. Because, in the absence of complete information, our mind needed to rely on something to help us figure it out. That is unconscious bias! Perhaps now you can see why unconscious bias doesn't make you bad inherently, but once you realize it exists, you are empowered to take action.

2020-21 Legislative Session Winding Down - How Did AAUW California-sponsored Bills Fare?

Not particularly well, as it turns out! We started the year off with 39 bills we selected for varying degrees of support. We chose one bill to co-sponsor, AB 92 (establishing a sliding scale for family fees for childcare through 2023), with four additional bills for top-priority attention ("A" level), five bills for "important" status ("B" level), twenty-two bills for low ("C" level) attention, and seven bills to "watch."

Over-all, 28 of our 39 bills have been designated "2-year" bills, which means they are dead for this year and likely will be taken up again in 2022. Our advocate, Kathy Van Osten, has explained that this is because Senate and Assembly leadership set a limit of just 12 bills that a member could move to the second house, so members had to pick and choose what would they wanted to move forward.

Some of our bills did not make the cut. Four of our five top priority bills, along with our co-sponsored bill, and four of our other bills, did not make it through. These include AB 22, AB 92, AB 737, AB 966, AB 1361 (all promoting varied preschool and transitional kindergarten issues), and SB 245 (no cost-sharing for abortion services). However, several of them were converted into the Budget and Budget "trailer bills," which will provide funding for childcare. Although we were not entirely successful in getting our top bill AB 92 passed, the state budget includes \$60 million for one year of relief for all families using subsidized childcare, increased reimbursement rates for childcare providers, and funding for 206,000 new childcare slots.

Several bills have passed and been sent to the Governor, and we are working hard to secure his signature on these bills: AB 62 (upgrade garment worker wages) and AB 367 (free menstrual products), as well AB 123 (paid family leave), AB 1074 (rehire displaced workers), and AB 1461 (health services for non-citizens).



An Update on Reagan Beers, Past Local Scholarship Recipient

Reagan Beers was awarded the Edie Kerr Founder's Scholarship from AAUW Local Scholarship in the spring of 2020. Shortly afterwards she completed a remote summer internship in the Building Energy Science Department at the National Renewable Energy Laboratory, a department that focuses on renewable energy

technology for commercial buildings. For her project, Reagan worked with an engineering team to evaluate material compatibility for an energy efficient heating, ventilation and air conditioning (HVAC) system. Aside from doing literature searches, designing experiments and analyzing data, she was expected to give oral presentations and written reports. At weekly meetings, she presented their data to the engineering team and answered their questions. These weekly meetings gave her practice for when she showcased her research at a virtual poster symposium and submitted a comprehensive report of her findings and progress to the U.S. Department of Energy.

The knowledge and skills Reagan gained from her internship prepared her to join the Sailor Research Group last fall at the University of California-San Diego and begin her undergraduate research. The data from her first project was then delivered to their industrial partner to be safely translated to an industrial scale. Although she spent most of her time repeating experiments and troubleshooting instruments, she used that as an opportunity to practice her lab techniques and problem-solving skills and to gain experience working in a professional research setting.

During the summer, Reagan worked with two graduate students in her research group on a process to deposit catalysts into silicon nanostructures to degrade chemical warfare agents. These nanostructures will then be integrated into fabrics, lotions, eye drops and contact lenses to offer dermal and ocular protection. She has also been researching full time and mentoring an undergraduate participant in the Sailor summer research immersion program. In this new academic year, Reagan continues to take classes and work on her research project. She expects to graduate with a B.S. in Chemistry in Spring 2022 and ultimately intends to get a Ph.D. in Materials Science and Engineering.

When she's not studying or working, Reagan "loves to cook, dance and enjoy the sunshine."

A Special Update on Christina (Long) Duarte, Past Local Scholarship Recipient

Christina was awarded a Local Scholarship in 2013 while attending Evergreen Valley College, where she received an AA degree in Paralegal Studies. Christina credits her career advancement at least in part to receiving this scholarship. At the time she had been considering leaving the program to work full time if she couldn't get a scholarship



to help cover costs. Instead, she was able to complete her AA. In 2014 she was granted a second scholarship while at UC Santa Cruz. Upon graduation in 2015 with a degree in philosophy, she immediately started working for a small estate planning law firm. Subsequently she relocated to San Jose and started working for a boutique family law firm.

A few years ago, Christina took a new position at a much larger family law firm and worked as a legal administrative assistant until her twins were born in September 2020. The twins were born six weeks early so she had a brief NICU stay right in the middle of COVID. She had an extended maternity leave, but thanks to the paralegal certification she earned at Evergreen, she was qualified to work as a paralegal. She was offered a promotion at her current law firm before even returning from maternity leave and started in her new position as soon as she returned to work.

Christina credits her moving up over the last few years in large part to being a Local Scholarship recipient. She adds that she is now in a position to pay that forward and intends to donate to the scholarship fund. She hopes that sharing her story will help attract future donors for future scholarships! She adds that, due to the promotion and higher income level, her husband was also able to return to grad school and is currently working on his Master's in materials engineering, while also staying home with the babies part time.

Commenting that they've done things a bit unconventionally, Christina notes that it's amazing to know that she can be a mom (to two at a time!) and still have a flourishing career that's both fulfilling to her and supports a family of four. With one-year old twins, her for-fun activities have been relatively limited lately, but she and her husband are eager to get back to their outdoor activities as the babies get older. They enjoy hiking, trips to Santa Cruz to walk along West Cliff or hike trails along the beach, or explore the hidden gems in small cities and downtown areas.

Yanet Gutierrez is our third featured NCCWSL recipient. She graduated from San Jose State in May 2021 with a bachelor's degree in political science (cum laude). She is working through the learning process of applying to law schools. Like so many

first-generation students, she didn't have any guidance and has been learning the process for a successful application to law school.

As she said, "After reflecting and thinking how hard I have worked to obtain an education, and the support of many people and organizations that have helped me, I decided to give it another chance and not to think about these rejection letters as an obstacle; instead, these should give me courage to give my everything. Also, I thought about my father, and what he would like me to do. I'm sure he wouldn't be happy, he would encourage me to try again, again, again and again."

She got lucky and learned that UC Davis offers a program called King Hall Outreach Program. It provided great tools and knowledge on how to prepare a resume, personal statement and how to find the schools that fit her skills, test scores and financial aid. She's preparing for her LSAT and will apply to the schools that are a right fit.

In the meantime, she's gaining experience doing volunteer work. Prior to our Fall Gathering she was doing volunteer work for the California Fire Relief Program through a non-profit called All Hands and Hearts, an organization that focuses on disaster relief work. Additionally, she's also focusing on helping other students by connecting them with resources.
